**MEASURING**

All measurements need to be done by **7:45 AM** each day. You need to get your dog measured prior to checking in unless you have a permanent height card. There will be no measuring of dogs after the stated time each day. All dogs without permanent height cards must be measured to show.

**JUDGING / WALK-THROUGHS**

The first walk-through each day will be at **8:00 AM**, with the first dog on the line at **8:15 AM**. The rest of the classes to follow.

**SET-UP**

The building will be open to exhibitors beginning at **6:30AM Saturday, 7:00AM Sunday**. There is NO Friday exhibitor set-up.

**FOOD**

There is no food vendor on site but fast food restaurants are very close by.

**RV PARKING**

There are NO hook-ups; RV's and trailers may be parked overnight, but must be self-contained, NO DUMPING.

**CRATING**

This is a heated facility. There is **limited** indoor crate space available, please be considerate in your use of crating space. Use x-pens for multiple dogs only. No personal tables allowed in crating area. Crates and pens may be left overnight at the facility. Buckeye Region Agility Group does not assume any responsibility for personal property left on the site. **Only dogs entered in the trial are allowed in the building due to limited space.** Parking and the RV area are both close enough to make working out of your car convenient as well.

**GENERAL INFORMATION**

Hotels and sites for dog shows are getting more and more difficult to find, do your part; keep it clean! **Please clean up after your dogs** at the trial site and hotel.

**DIRECTIONS**

The training center is on the WEST side of Columbus. It is INSIDE the I-270 loop around Columbus just minutes south of I-70. The entrance door is on the **second** drive, on the north side of the front building.

From the north: I-71 south to I-270 west. Take I-70 East. Exit at Wilson Rd. (first exit on I-70. Stay in right lane) Turn left. (0.4 miles) Go to first traffic light, Fisher Road, and turn right. (0.7 miles) There is a Grismer Tire Center on the corner. Go to Distribution Dr. Turn right. Turn right at first driveway to 800 – 830 Distribution Dr.

From the south: I-71 north to I-70 west. Exit at Hague Ave. Turn right on Hague. Go to first light - Fisher Rd. Turn right. Go to Distribution Dr. Turn right. Turn right at first driveway to 800 – 830 Distribution Dr.

From the east: I-70 west to Wilson Rd. Exit at Wilson Rd. Turn left. (0.4 miles) Go to first traffic light, Fisher Road, and turn right. (0.7 miles) There is a Grismer Tire Center on the corner. Go to Distribution Dr. Turn right. Turn right at first driveway to 800 – 830 Distribution Dr.

From the west: I-70 east to Wilson Rd. Exit at Wilson Rd. (first exit on I-70. Stay in right lane) Turn left. Go to first traffic light, Fisher Road, and turn right. There is a Grismer Tire Center on the corner. Go to Distribution Dr. Turn right. Turn right at first driveway to 800 – 830 Distribution Dr.
